 ✓ A scheme called Biosphere Reserve is being implemented by Government of India since 1986.
 ✓ financial assistance -90:10 to North Eastern Region States and three Himalayan states
 ✓ 60:40 to other states for maintenance, improvement and development of certain items.
 ✓ State Government prepares the Management Action Plan which is approved and monitored by Central MAB Committee"

About United Nations Educational, Scientific and Cultural Organisation (UNESCO)

✓ UNESCO → specialized agency of the United Nations (UN) based in Paris.
 ✓ Its declared purpose is to contribute to peace and security by promoting international collaboration through educational, scientific, and cultural reforms in order to increase universal respect for justice, the rule of law, and human rights along with fundamental freedom proclaimed in the United Nations Charter.
 ✓ UNESCO pursues its objectives through five major programs: education, natural sciences, social/human sciences, culture and communication/information.
 ✓ world cultural and natural heritage (World Heritage Sites) and to preserve human rights, and attempts to bridge the worldwide digital divide.
 ✓ It is also a member of the United Nations Development Group.
 ✓ India was re-elected as member of executive board of United Nations educational, scientific and cultural organization (UNESCO).
 ✓ Executive board is UNESCO's top decision-making body.

Objectives of Biosphere Reserves

✓ In-situ conservation of biodiversity belonging to natural, semi-natural ecosystems and landscapes.
 ✓ Contribution to sustainable economic development of the human population housed within and around.
 ✓ Provide logistical facilities for long term ecological studies, environmental education and training and research and monitoring

Biosphere Reserves of India

✓ MoEF → provides financial assistance to State governments for conservation of landscape, diversity and cultural heritage.
 ✓ Ministry also provides support for research, monitoring, education and information exchange of the respective biosphere reserve.
 ✓ 18 Biosphere Reserves in India.
 ✓ These biosphere reserves often include one or more National Parks and Reserves, along buffer zones that are open to some economic uses.
 ✓ protection is granted to the flora and fauna of the region.

Criteria for designation of Biosphere Reserves

✓ site must contain an effectively protected and minimally disturbed core area of value of nature conservation.
 ✓ The core area should be able to sustain viable populations representing all trophic levels in the ecosystem.
 ✓ The area should have potential for preservation of traditional tribal or rural modes of living for harmonious use of the environment
